Guddiggu fadhigoodii ugu horeeyay oo qabsoomay **3/05/2015** waxay ku dajisteen qorshe hawleedkoodii ay ku shaqayn lahaayeen , iyado qoraalo kala gaar -gaar ah loo kala gudbiyay **saddexda xisbi qaran iyo koomishanka doorashooyinka** , si loo dhagaysto aragtiyohooga kala duwan ee ay ka qabaan dib-udhaca doorashooyinka ku yimid iyo wakhtiga ku haboon ee ay u qabsoomi karaan si sharciga waafaqsan .

Kullankii ugu horeeyay wuxuu Guddigu ka dhagaystay si kala gaar-gaar ah labadda Xisbi ee kala ah **UCID iyo WADDANI 05/05/2015**.

Sidoo kale waxay Guddigu **kullankoodii labaad-(2aad)** la kala yeesheen **xisbiga kulmiye iyo Koomishanka Doorashooyinka qaranka(KDQ) 06/05/2015.**

Kullamaddaasi waxa lagu dhagaysanayay araa'da ay qabaan iyo wixii tallooyin ah ee ay soo jeedinayeen . Markii uu dhagaystay warbixintii Guddigga oo ay ku ladhnaayeen fikradihii,aaraadii , iyo tallooyinkii seddexda xisbi qaran iyo komishanka doorashooyinka;

Markii uu qiimeeyey xaaladka , iyo duruufaha ka jira Gobolladda iyo Degmooyinka Bariga iyo guud ahaan ba dalka **JSL** ;

Markii uu lagama-maarmaan u arkay in ay ka suurto-galaan Diwaan-gelinta muwaadinka iyo cod-bixiyeyaashu dhammaanba dalka **JSL** , si ay u suganto is- raacsananta dhul ahaaneed iyo dad ahaaneedba ee Dastuurku waajibiyay ;

Markii uu yaqiinsaday in go'aankii ay ku cayimeen Koomishanku wakhtiga doorashadu u ahaa mid baalmarsan, waa faqsanayna Dastuurka iyo shuruucda dalka, iyago sammeeyay muddo korodhsimo anay awood sharciyed u lahayn ;

2- Waxa muddo xileedkii Madaxwaynaha iyo ku xigeenka Madaxwaynaha oo ku eg 27/7/2015, lagu sammeeyay korodhsimo ka bilaabmaysa 28/7/2015 illa 27/4/2017.

3- Golaha Wakiiladda oo dhammaadka muddo xileedkoodu ku egyahay 27/7/2015, lagu sammeeyay muddo korodhsimo ka bilaabmaysa 28/7/2015 illa 27/4/2017.

4- Muddo xileedka Golaha Guurtiddu wuxu noqonaya hal sano ka dib (**one year after**) dhammaadka muddo xileedka **Golaha wakiiladda** oo noqonaya **27/4/2017**, sida waafaqsan ama ku cadba go'aanka lambar **GW/KF-19/245/2003 ee 29/03/2003**, una dhigan "in muddada xilka **Golaha Guurtiddu** markastaba hal sano ka dambayso taariikhda dhammaadka muddada xilka Golaha wakiiladda".

5- Doorashada Maddaxtooyada iyo Golaha Wakiiladdu waxay qabsoomayaan isla hal wakhti, ahna bil ka hor dhammaadka muddo xileedka loo kordhiyay , oo **waafaqsan qoddobadda 42aad iyo 83aad ee Dastuurka Dalka Jamhuuriyada Somaliland .**

- Iyadoo xukuumaddu horumuud ka ah , waa in si deg-deg ah qorshe dhammaystiran oo iskaabaya (comprehensive and special programme) oo qaran lagu wajaha Gobolada iyo Degmooyinka Barriga , oo laga taabo- galiyaa maamul adag iyo amni, si looga suurto-galiyo diwaangelin muwaadin , cod-bixiye iyo doorashaba .

- Qabyooyinka dhinaca xeerarka Goleyaasha (Wakiiladda iyo Guurtiddaba) iyado xukuumaddu ku hoggaaminaysa waa in si wada jir ah oo xil-kasnimo ku jirto loo dhammaystiraa , qorshe deg-deg ahna laga yeesha . waajibaad gudasho la'aan ayay noqonaysaa haddii aan loo qalab qaadanin dhammaystirka qabyooyinka dhinaca shuruucda .
- Golaha Guurtidda waxa ku waajib ah isagoo gacan-siinaya xukuumadda inuu ka qayb qaato iskuna diyaariyo adkaynta nabadgalyada iyo wacyi-gelinta bulshadda qaybaeeda kala duwan.
- Golaha wakiiladda waxa ku waajib ah in uu meel-mariyo qaybna ka qaato hindise sharchiyeedyada qaranku u bahan yahay si fir-fircooni oo xilkasnimoo ku jirtana u gutaan waajibaadkooda Dastuuriga ah .
- Koomishanka Doorashooyinka Qaranka waxa waajib ku ah in ay ku tallo -galaan siddi Degmo kasta iyo Gobol kasta looga hirgalin lahaa diwaan-gelin muwaadin , codbixin iyo doorashaba.
- Koomishanka Doorashooyinka qaranku , waa in ay ku tallaabsadaan barnaamij wax ku ool ah oo horseedaya doorashooyin xor iyo xalaal ah, qof kastaana ku dhiiban karo hal cod oo keliya, isla -marahaan -taana siiyan muwaadiniinta isdiwaan-gelinaysa wakhti ku filan.
